Background

The Agricultural Leaders for Alabama program is designed to be a two-year intensive learning experience focusing on personal development, political involvement, effective communication and understanding of the Alabama Farmers Federation. This is the fourth A.L.F.A class. Previous class members now serve as county presidents, county board members, and as leaders on the county, state and national levels. This class will be comprised of six seminars scheduled over a two-year period.

Eligibility

- Applicants should apply individually. Spouses will not be selected to participate in the same class.
- Applicant must demonstrate leadership qualities and potential as evidenced by community, political or organizational activities.
- An applicant's character, reputation and personal life (as evidenced by references or inquiry) must be of the highest quality, reflecting potential leadership capability.
- Although there are no specific academic requirements, applicants must be able to demonstrate potential to contribute meaningfully to seminar sessions and perform outside assignments as required throughout the two-year program.
- Applicant shall be an Alabama Farmers Federation member between the ages of 25 and 45 in good standing with his/her county Federation.
- Applications submitted without membership numbers and/or all signatures will not be accepted.
- Participants in previous classes are not eligible, but applicants not previously selected are eligible to apply again.
- Three letters of reference must be submitted with this application. Your application will not be considered unless it contains three letters. One of these letters must be from your County Farmers Federation President.

Entry Form & Application Guidelines

- Applications MUST be typed.
- Do not use abbreviations or acronyms.
- Recreating the application on a computer is not allowed; this includes font and format changes, such as bolding.

Expectations

- Attendance for all seminars is expected with exception of emergencies. Applicants must participate in a minimum of 85% of the program to be eligible to participate in the out-of-state agriculture experience or the session in Washington, D.C.
- An applicant who is not self-employed must have employer approval. If you are not self-employed, please have your supervisor sign the following page and submit a letter of reference. This letter may count as one of the required three.
- Self-employed applicants must establish their ability to be away from their enterprise for all scheduled seminars.

Selection

- Applicants are evaluated by an independent selection committee on their ability to communicate (written and verbal) their reasons for wanting to participate in the program; their understanding of industry trends and issues; their ability to serve in leadership roles; and that the nature of their interest in leadership service expands beyond self-interest and narrow perspectives.
- Full consideration will be given to all applicants. Every effort will be made to select a class, based on the applicant pool, which is representative of the entire agricultural industry, its diversity and rural community interests.
- Finalists will be selected from the initial application review and invited to participate in a personal interview. The committee will make its final recommendation based on this 20 minute interview and the application submitted.
- Applicants will be notified if they are a finalist by April 1, 2016 and will be assigned an interview time and date.
- Interviews for finalists will be held on April 18-19, 2016. All applicants should hold these dates until you have been notified on April 1.

Cost

- The cost for the entire program is \$5,500 per person. You are asked to cover \$1,500 of the total cost.
- Invoices will be sent to class members in mid-August and will be due by September 30, 2016. You may pay the cost yourself, or arrange sponsorship through your County Farmers Federation or another agriculture organization. You may also work with your employer to cover the cost.

Deadline

Deadline for entry is March 15, 2016. No late applications will be accepted. Applications must be received **SIGNED and complete with all pages** by March 15, 2016 at 4:00 PM CDT.
